## MEMBERSHIP APPLICATION GUIDELINES

### A) Membership Types and Fees:

Membership Types	Entrance Fees	Annual Fees

### B) Rights:

1. Have the right to vote;
2. Participate in Society's activities;

### C) Membership Year and Discounted Membership Fee:

1. Membership year commences on 1 January and ends on 31 December of the same year.
2. For membership application submitted on or after 1 July, the annual membership fee is half of the original.
3. Please pay the membership fee only after the application is approved.

### D) Membership Application Procedures:

1. Members should abide by the rules set out by Japan Society.
2. The approval of an application shall require a simple majority vote of the Members of the Councils. Japan Society reserves the right to reject any application for membership without giving any reason.

### E) Personal Information Collection Statement:

1. The personal data collected by means of this form will be used by Japan Society for the following purposes:
  - i. Considering and processing membership applications; and
  - ii. Communicating with members in relation to all news, notices and information of Japan Society as well as all activities in line with the objectives of Japan Society.
